

98.1 WOGL-FM VACATION-A-DAY OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE ENTRANT'S CHANCE OF WINNING.

1. HOW TO ENTER

a. These rules govern the Vacation-A-Day promotion (the "Promotion"), which is being conducted by Philadelphia CBS Radio East Inc. d/b/a WOGL-FM (the "Station"). The Promotion begins on January 4, 2018 and ends on December 14, 2018 (the "Promotion Dates"). There will be no Promotion conducted on the following days: January 15, 2018, February 19, 2018, May 28, 2018, July 4, 2018, September 3, 2018, November 22, 2018, November 23, 2018, and possibly December 6, 2018 and December 7, 2018. (Dates subject to change)

b. To enter the Promotion, entrant may enter as follows:

i. First, entrants must visit www.wogl.com, click on the 98.1 WOGL Listener Club link and complete the online entry form to register as a member of the 98.1 WOGL Listener Club any time prior to 10:00am Eastern Time ("ET") on December 14, 2018. Entrants must provide their first and last name, gender, date of birth, e-mail address, city, state and zip code. **Membership is free.** Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or 98.1 WOGL Listener Club account. Multiple participants are not permitted to share the same email address or 98.1 WOGL Listener Club account. P.O. Boxes are not permitted. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Promotion administrator. Existing 98.1 WOGL Listener Club members will be automatically entered in the Promotion and do not need to re-register in order to participate in the Promotion. If you have changed your address and/or phone number, please visit www.wogl.com, click on the 98.1 WOGL Listener Club link on the website and follow the instructions to update the information.

ii. After joining the 98.1 WOGL Listener Club online as described above, entrant must listen to the Station each weekday beginning on January 4, 2017 and ending on December 14, 2018 between the hours of 10:00am ET and 5:00pm ET for the announcement of a potential winner's name. Each weekday, the Station will randomly select one (1) member of the 98.1 WOGL Listener Club from all members who have joined the Listener Club by the time of the drawing. The Station will announce on-air the name of the randomly selected potential prize winner anytime between 10:00am ET and 5:00pm ET. The announced potential prize winner will have sixty (60) minutes beginning at the time of the on-air announcement to call the Station at 1-800-942-8998 and identify himself/herself. If the announced potential prize winner calls the Station within the allotted sixty (60) minutes, they will win a prize upon confirmation of eligibility. Station will be the official timekeeper for this Promotion at its sole discretion. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth in order to verify eligibility. In the event that the announced entrant fails to call the Station as directed following the on-air announcement, the entrant will not receive a prize. Alternate names may continue to be randomly drawn until 5:00pm ET at the sole discretion of the Station unless there is a winner before that time each weekday. If a prize is not awarded by 5:00pm ET on any given weekday, then no prize will be awarded that weekday. If a potential prize

winner does not call within the allotted sixty (60) minutes, their name will remain eligible for any future random drawings, if applicable.

c. There may be up to a total of two-hundred and thirty-eight (238) winners selected in the Promotion.

d. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests. Entrants are encouraged to listen to the Station on-air. The Station is not responsible for online streaming delays.

2. ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all individuals who are both 21 years of age or older and legal Pennsylvania, New Jersey and Delaware residents on the entry date may enter Station contests ("Entrant(s)" Void where prohibited or restricted by law. Employees, officers, directors and agents of Apple Vacations, the Station, Entercom, their corporate affiliates, Station's advertising and promotional agencies, participating sponsors, prize suppliers, their respective affiliates (collectively, the "Promotion Entities") and other radio stations in the Philadelphia metropolitan area, the members of their immediate families (spouse, parents, siblings or children) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

b. Listeners are eligible to win prizes in a Station-conducted Promotion only once every twenty-four (24) hours and prize(s) valued at \$600 or more only once every six (6) months. Only one (1) winner per household is permitted in any Station-conducted promotion.

c. The winner(s) may be required to present valid government-issued photo identification and must provide winner's complete address, date of birth and phone number to claim a prize(s).

d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

3. PRIZES

a. Up to two-hundred and thirty-two (232) prizes may be awarded. Each prize is one (1) certificate that can be redeemed for a Caribbean trip provided by Apple Vacations. Trip destinations will change weekly (destinations will be announced by the Station each time a cue to call is given). Each certificate includes the following: (i) two (2) round trip charter air tickets via a Philadelphia based airline from a Philadelphia area airport to a pre-selected airport near the resort location/destination; (ii) all-inclusive accommodations for three (3) nights (standard room, double occupancy) – all-inclusive is all meals, drinks (alcohol and non-alcohol), tips and non-motorized water sports (refer

to www.applevacations.com for the specifics on each hotel as each hotel has different activities that are included); and (iii) round trip resort transfers. The Approximate Retail Value (“ARV”) of each prize is \$1500. Actual value may vary based on point of departure and dates of travel. Any difference between stated value and actual value will not be awarded. Trip is for two (2) adults for three (3) nights/ four (4) days. Note that only two (2) adults are allowed per room (for purposes of the prize package adults are considered to be anyone over the age of 12). Trip does not include flight taxes (US & Foreign departure taxes and airport user fees). Taxes are subject to change at any time including fuel surcharges; **DE and PA residents will be subject to a fuel surcharge of \$160 per person and insurance of \$74.99 per person.** Trip does not include any incidentals or optional excursions. Winners and travel companions are solely responsible for all applicable taxes, including, but not limited to, hotel, hospitality and airport taxes, telephone charges, transfers, spending money and any other expenses not specifically offered herein. Blackout dates include the following – five (5) days before and after the following holidays: New Year’s, President’s Day, Easter, Memorial Day, 4th of July, Labor Day, Thanksgiving, Christmas. Certain hotels/resorts may also blackout winner’s requests when occupancy is at extremely high levels, at its sole discretion. Trip must be taken within 6 months of winning. Certain travel restrictions may apply. Travel arrangements must be made through the Station or its designee. Prize(s) is subject to availability. If the winner(s) cannot travel on date(s) specified by the Station, the winner(s) may be disqualified, and an alternate winner(s) may be selected (time permitting) at the Station’s sole discretion. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport and/or to/from the hotel, are the responsibility of the winner(s). Travel must be round trip. Station will determine itinerary and airline, if applicable, in its sole discretion. The winner(s) and guest(s) must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. Airline regulations apply. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner’s stay. The winner(s) and guest(s) must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Promotion Entities, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. The prize certificate will be subject to the terms and conditions as set forth by the issuer of the prize certificate. Prize certificates are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will prize certificates be replaced if lost or stolen. Travel valid for six months.

b. No more than the stated number of prizes specified in these official rules will be awarded. All prizes or prize certificates must be claimed at the office of the Station at the address below during regular business hours. The winner(s) will forfeit any prize(s) or prize certificate(s) not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed or shipped to the winner(s), it will be with the prior written consent of the winner(s) and therefore, winner(s) assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize(s) or prize certificate(s).

c. Prize(s) is not transferable, and no substitution, assignment or cash equivalent of prize(s) is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value. The prize(s) are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Promotion Entities are not responsible for winners’ limitations that prevent acceptance or use of prize(s). Entrants acknowledge that the Promotion Entities have not made, and are not in any manner responsible or liable for, any warranties,

representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability, mechanical condition or fitness for a particular purpose. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

a. Decisions of the Station management with respect to the Promotion are final.

b. Up to two-hundred and thirty-two (238) winners will be selected in the Promotion. Up to one (1) winner may be selected each weekday during the Promotion as described in Section 1 of these Official Rules.

c. Odds of being selected as a potential winner depend on the number of 98.1 WOGL Listener Club members at the time of each respective drawing.

d. Winners must listen to the Station to win but do not need to be present to win.

e. Prizes will be awarded only upon confirmation of eligibility and completion of all requisite releases. The winner(s) must execute and complete any required affidavit of eligibility and/or liability/publicity release within thirty (30) days of winning or prize(s) will be forfeited and no alternate winner will be selected. If a winner has not reached the age of majority in his/her state of residence, the prize(s) will be awarded in the name of his/her parent or legal guardian. If a potential winner(s) cannot be contacted, fails to sign and return the required fully-executed affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize(s). All winners will be required to create an appointment time to visit the station and meet with the Promotion Director to complete all necessary paperwork, release forms and tax related paperwork within 30 days of winning.

5. CONDITIONS

a. Payments of all federal, state and local taxes are solely the responsibility of the winner(s). The winner(s) may be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize(s) and will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize(s) valued at \$600 or more or for any prizes awarded by the Station (or any other CBS Radio station in Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize(s). Such winnings of \$600 or more will be reported to the IRS.

b. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) permission for the Station or its designees to interview the winner(s) (or guest(s), if applicable), to photograph, film and record each winner (or guest, if applicable), and to use in commerce and in any media, now or hereafter known, throughout the world, in perpetuity,

his/her name, prize(s) won, hometown (city and state), biographic information, likeness, photograph, voice, audio or video recording and/or any statements made by him/her regarding the Station, the Promotion and/or its sponsor(s) for purposes of trade, publicity or promotion without notice or additional compensation, notification or permission, in perpetuity, except where prohibited by law. Each winner (and guest, if applicable) agrees to sign a publicity release confirming such consent prior to acceptance of the prize, except where prohibited by law.

c. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) agreement to release, discharge, and hold harmless the Promotion Entities and their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns (collectively, the "Released Parties") from and against any and all claims or liability arising directly or indirectly from any prize(s) awarded and participation in the Promotion, including, but not limited to, personal injury, death or damage to or loss of property, which may occur in connection with, preparation for, travel to, or participation in the Promotion, or delivery, possession, acceptance and/or use or misuse of any prize or participation in any Promotion-related activity, including, but not limited to, any claims based on publicity rights, defamation, invasion of privacy and merchandise delivery.

d. If for any reason this Promotion cannot be executed as planned, including but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Released Parties that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend and/or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right, in its sole discretion, to modify the procedure for selecting winner(s), unless the nature of the event giving rise to such termination renders it impossible to select winner(s).

e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize(s); (ii) incorrect or inaccurate entry information, human error, failure or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection or equipment malfunctions or any other technological problems or failures of any kind; or (vi) any cancellations, delays, diversions, substitutions or omissions whatsoever by any transportation providers or any other persons or entities providing any services to winner(s) (and guest(s), if applicable) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism or other factors beyond the Released Parties' control.

f. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that entrant's entries and that entrant may be disqualified. The use of any device to automate entry is prohibited. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that entrant at the Station's discretion. The Station's or its Promotion administrator's computer or telephone system is the official time keeping device for this Promotion. In the event of a dispute, online entries

will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address or (ii) is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Promotion. Failure to comply with the rules of the Promotion may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.

g. The Station reserves the right to make changes to the rules of the Promotion, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Promotion Entities, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the Promotion and shall not be required to award a substitute prize(s).

h. Except where prohibited, by entering the Promotion, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in New York, NY; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. New York law governs the interpretation and construction of these Official Rules and all aspects related thereto.

i. a. By participating in the Promotion, entrant agrees to the Station's Terms of Use Agreement and to the use of entrant's personal information as described in the Privacy Policy located at wogl.com. In the event of conflict between the Station's Terms of Use Agreement and these Official Rules, the terms of these Official Rules shall apply.
